Understanding how important this is for our youth, the Congress of Aboriginal Peoples' National Youth Council (NYC) established this unique awards program to honour and show appreciation to both achievements and advocacy.

"We feel that Aboriginal youth in Canada are realizing goals and deserve to be recognized for both their efforts and achievements. We want youth to know that the journey is as important as the destination. For that reason this award is also based on effort and not entirely on accomplishments." - NYC Member

Award Criteria – Youth Award

Any person in Canada be nominated for an award, so long as they:

- are between the ages of 15 and 29 by the deadline;
- are of Aboriginal ancestry;
- are not a previous winner.

Award Criteria – Adult Youth Advocacy Award

Any person in Canada be nominated for an award, so long as they:

- Are aged 30 or over by the deadline;
- are of Aboriginal ancestry;
- are not a previous winner.

CONGRESS OF ABORIGINAL PEOPLES' NATIONAL YOUTH COUNCIL

Both Awards:

The nominator (if applicable) or applicant must send in all of the following documents:

- Letter about the applicant;
- Two of the following:
 - A signed support letters from a non-relative;
 - A signed letter from a youth you've advocated for;
 - A signed letter from organizations
- Applicant resume;
- Current color headshot of the applicant and;
- Completed application form with signatures.
- If a resume is cumbersome, please feel free to submit a video presentation highlighting advocacy and achievements.

Incomplete applications will not be accepted.

The award recipient will receive a cash award (amount to be determined based on monies fundraised by the NYC).
